Variance Application #VA-25-07, Richard E. Bale

Seeking an area variance from the Orange Township Zoning Resolution Section 7.06(a) to allow a new parcel to be less than the minimum allowable lot area. The subject property is located at 6210 Bale-Kenyon Road, Lewis Center, OH 43035 and having parcel number 318-143-01-001-000.
